

Information on the processing of personal data

This statement, pursuant to art. 13 and 14 of the EU Regulation 2016/679 (hereinafter called “GDPR”) describes the purposes and methods by which Your personal data are collected and handled, which data categories are processed, what are the rights You are entitled to exercise and how You can do it.

The above mentioned subjects wish to inform You that the data collected will be used by each of them in compliance with the legislation in force and according to the purposes and methods indicated in this privacy policy.

Purpose of processing and lawful basis

In the framework of the European project ENISIE, the personal data collected through the filling in and submission of the questionnaire (personal data including name, surname, e-mail address) will map the existing innovation enterprises in order to boost the companies and provide innovative services.

Failure to provide the data marked with an asterisk, the so-called mandatory data, will not allow You to apply.

Data processing shall be based on the consent of the data subject.

The data collected will be used to communicate to the concerned parties the progress of the project and may be used in the future by the joint Data Controllers to inform the data subjects about similar initiatives.

The data collected will be also processed for administration purposes and will be communicated to the Regione Sicilia (Sicilian Regional Government) for reporting purposes.

Data processing methods

The data will be processed following methods and procedures strictly necessary to achieve the purposes for which they were collected, both manually, and/or with the aid of electronic devices.

In order to avoid any risks of data loss, of illicit or incorrect use, of unauthorized access or alterations of any kind, security and management technological measures have been adopted.

The personal data will be processed by the Joint Data Controllers or also by external Managers specifically appointed for the purpose of this information notice.

Personal Data Storage Time

All personal information subject to processing will be stored throughout the whole project and even after, for the time needed for the project output.

The e-mail addresses will be kept until the data subjects request their cancellation.

Rights of the data subject
